Axcess relationships	Adrian acts separately as an Axcess Capital Advisors Inc. Dealing Representative when performing registration-dependent activity. Peter's separate Axcess relationship is referral-only and may include alternative-investment and private-wealth referrals.
Discretionary portfolio management	The independently registered portfolio manager under its own agreement, registration, custody, fees and disclosures.
Peter's professional services	The separate person or legal organization identified in the applicable engagement and disclosure documents. Reset Report content does not create that engagement.
